On behalf of **Ghatte Khola Micro Hydro Project User's Committee (GKMHPUC)**, AEPC invites Electronic Bids for the **Construction (Supply, Delivery, Installation, Testing and Commissioning of Electro-Mechanical works) of Ghatte Khola MHP (19kW), Chankheli Rural Municipality-3 Humla District** at under National Competitive Bidding (NCB) procedures as specified in prevailing Public Procurement Act and Public Procurement Regulations of Nepal. Bidding is open to all eligible National Bidders. The estimated amount for the Works is **NRs. 9,016,662.55**, exclusive of VAT. Only eligible bidders with the following Key Qualifications should participate in this bidding:
 - Accumulated Minimum Work Experience in similar nature: Construction or Supply, Delivery, Installation, Testing and Commissioning (Construction) of Hydropower Project at least 12 kW.

Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by scanned copy of the bid security in PDF format, amounting to a minimum of **NRs.250,000.00** which shall be valid for minimum 30 days beyond the bid validity period (i.e. Valid up to minimum **5 July 2021**).
